

FaithCare Health Services Agreement

Provided by Faith Community Health Center, Inc.

FaithCare is an employer-based healthcare services benefit plan offered by Faith Community Health (FAiTH). *FaithCare* provides access to affordable primary and virtual healthcare for uninsured employees working in Stone or Taney counties, in Missouri. **FaithCare is not health insurance.** Services are provided by Faith Community Health Center, Inc., a nonprofit medical clinic located in Branson, Missouri. FAiTH operates on a cash basis and does not accept health insurance reimbursement for services. This is a medical retainer agreement for the provision of direct primary care in the state of Missouri.

Employer Commitment: The undersigned acknowledges receipt of a complete listing of services detailed in the *FaithCare* Health Services information sheet as may be updated from time to time online and commits to abide by the terms of the Participation Options described therein.

Term: This agreement is for the duration of Employer’s participation in *FaithCare*. Services are provided month to month. No term of contract is required. Employer may opt to discontinue participation at the end of any month. Either party may elect to terminate this agreement upon written notice to the other.

Provision of Services: FAiTH agrees to provide services as described herein upon receipt of payment. No services will be provided whenever payment in full has not been received for the service period.

Payment Schedule: Payment for services is due in full no later than the 25th of the month preceding the month for which payment is made. Employer agrees to provide a full listing of the individuals to be included in *FaithCare* membership each month at the time of payment. Open accounts with no active members will incur a \$5 dormant account fee.

FaithCare Health Services

Affordable Healthcare Services for Uninsured Employees

Description

FaithCare is a membership based healthcare services plan offered by Faith Community Health (FCH). It is designed to meet the primary healthcare needs of employees working in Stone or Taney counties who lack health insurance. ***FaithCare is not health insurance.*** Services are provided by Faith Community Health, a nonprofit medical clinic located in Branson, Missouri.

Services

- **Primary Care** Direct primary care medical services provided by FCH
- ***FaithCare Virtual Visits*** Online telehealth services powered by CoxHealth.
- **KwikCare** *KwikCare* services for select acute medical needs available in the FCH clinic.
- **Prescriptions** Access to most prescription needs is available through the FCH dispensary for members who qualify. Registration is required to verify income eligibility. Monthly fees apply for prescriptions dispensed at FCH. Members may choose to have prescriptions filled elsewhere.
- **Vision Care** Annual eye exam and access to low cost frames and lenses

Member Services Rates

- \$10 Primary Care visit
- \$10 *FaithCare Virtual Visit*
- \$10 *KwikCare* visit
- \$10/mo. Prescriptions, unlimited
- \$10 Vision Care exam
- *Misc. in-house lab and procedure fees, etc., at low FCH clinic rates

Employer Monthly Subscription Rates, per member

- \$29 ***FaithCare Medical***: Primary Care + Virtual Visits + *KwikCare* + Prescriptions
- \$5 ***FaithCare Vision***, optional: Basic vision exam + discounted eyewear
- \$30 ***FaithCare Advantage***: Includes both *FaithCare Medical* and *FaithCare Vision*, available only to members of participating associations

Participation Guidelines/Options

- **Minimum participation requirement:** *FaithCare* membership is required for all employees working more than 9 hours per week who are not offered health insurance options at your firm, have completed your probationary period for new hires, are not eligible for federal Health Insurance coverage, and do not have spousal coverage.
- **Optional:** Employer may elect to include employees who are eligible for employer's health insurance but have declined coverage, as a block. Individual election is not available.
- **Optional, spouses:** At employer option, uninsured spouses of employees may enroll in *FaithCare* membership at member rates on the same basis as employees, as a group.
